EXECUTIVE ORDER NO. 2010-002

CREATING AND CONVENING THE COMPOSITION OF THE CITY CENSUS COORDINATING BOARD IN CONNECTION WITH THE 2010 CENSUS OF POPULATION AND HOUSING (2010 CPH) IN MAY 2010.

WHEREAS, the National Statistics Office, mandated by the Constitution for generating general-purpose statistics and undertaking censuses and surveys will conduct the 2010 Census of Population and Housing in May 2010;

WHEREAS, the National Statistical Coordination Board has approved Resolutions and the Terms of Reference (TOR) for the convening and composition of the City Census Coordinating Board;

NOW, THEREFORE, I, JESSE M. ROBREDO, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1 – The City Census Coordinating Board (CCCB) is hereby constituted with the following composition:

SECTION 2 – Functions of the CCCB:

1. Conduct a publicity and information campaign on the forthcoming census;
2. Assist in the census operation to ensure the complete coverage of the city;
3. Provide security to census personnel and materials;
4. Provide, when necessary, the services of a personnel, on a temporary detail, to the District Office for the duration of the census operation;
5. Refer to the PCCB matters which cannot be resolved in the CCCB;
6. Enlist the cooperation of barangay officials in the census operation;
7. Ensure that the census returns are transported to the NSO provincial office at the earliest possible time; and
8. Take up other matters as may be specified by the PCCB or as necessary for the successful conduct of the census.
