

EXECUTIVE ORDER NO. 2011-032

CREATING A COMMITTEE TO INVESTIGATE THE OCTOBER 21, 2011 INCIDENT THAT RESULTED IN THE DEATH AND INJURIES TO 4GM CONSTRUCTION WORKERS

WHEREAS, the City Government of Naga, as the procuring entity, awarded to 4GM Construction the construction of the storm drainage along Dimasalang Street traversing Barangays Sta. Cruz and San Francisco for having had the lowest calculated responsive bid;

WHEREAS, at about 2 o'clock in the afternoon of October 21, 2011, the excavated portion of the storm drainage being constructed along Dimasalang Street, Barangay San Francisco in front of Nilo Roa Hospital caved-in resulting in the deaths of two (2) workers of 4GM Construction while two (2) other workers suffered injuries;

WHEREAS, there is a need to ensure an in-depth and impartial investigation of the incident and to recommend the proper courses of action insofar as the contract of 4GM Construction in the construction of said storm drainage is concerned;

NOW, THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, hereby constitute an **Investigation Committee** and, for this purpose, hereby appoint –

SECTION 1. Composition. The Committee shall be composed of the following:

HON. CECILIA VELUZ-DE ASIS – Chairperson, Project Monitoring Committee
HON. JOSE P. TUASON – Chairperson, SP Committee on Infrastructure
ATTY. PERFECTO N. BRAGAS III – City Legal Officer
MR. RAMIRO I. SAMAR – Chairman, Naga City People's Council
ENGR. MANUEL NEBREJA – President, PICE Camarines Sur Chapter
ENGR. SALVADOR ALDECOA – Representative from the Private Sector/Structural Engineer
MR. ELMER ABAD – President, Kapisanan ng mga Brodkaster ng Pilipinas-Cam Sur

The Committee shall convene on October 25, 2011 at 2:00 PM. The members shall elect from among themselves the Chairman of the Investigation Committee

SECTION 2. Functions. The Committee shall –

1. summon all parties and/or individuals concerned to submit themselves to a fact-finding investigation; and
2. submit a report to the City Mayor on or before October 28, 2011 of its findings and its recommendation/s.

SECTION 3. Effectivity. This Executive Order shall take effect immediately.
