EXECUTIVE ORDER NO. 2012-003-A

AMENDING EXECUTIVE ORDER NO. 2012 -003, ENTITLED, "ESTABLISHING THE MAYORAL SCHOLARSHIP FOR YOUTH EXCELLENCE IN SPORTS AND INSTITUTIONALIZING THE GRANTING OF CASH INCENTIVES TO WINNERS IN REGIONAL, NATIONAL AND INTERNATIONAL YOUTH SPORTS EVENTS BY DELETING THE PHRASE "BASED ON HIGHEST MEDALS" UNDER SECTION 3 THEREOF:-

WHEREAS, the City Government of Naga supports the national government's objective of building a healthy republic through excellence in sports as mandated by the Constitution of the Philippines which provides that "The state shall promote physical education and encourage sports program, league competition and amateur sports including training for international competition to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry";

WHEREAS, it has been the city's declared policy to protect and promote the right of its constituents to holistic education at all levels and recognize education as a priority program;

WHEREAS, establishing a scholarship program for winners in Palarong Panlungsod and institutionalizing the granting of incentives to winners in regional, national and international youth sports events will actualize the commitment of the City of Naga in democratizing access to quality education;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. ESTABLISHMENT OF THE MAYORAL SCHOLARSHIP FOR YOUTH EXCELLENCE IN SPORTS (YES) – (a) Elementary and high school student-athletes who won in the Palarong Panlungsod to be held in the month of July every year shall be entitled to this scholarship in the form of a stipend.

- (b) The following medalists/winners shall be entitled to the following sports stipend, to wit:
 - 1. Gold P400 per month
 - 2. Silver P300 per month
 - 3. Bronze P200 per month
- (c) The above sports scholarship shall be given to the winning athlete starting the month following the Palarong Panglunsod (from August every year, if the Palaro is held in July) up to March the following year, provided that the recipient participate in the Palarong Bicol. Non-participation in the Palarong Bicol for whatever reason shall automatically forfeit entitlement to the monthly stipend effective in the month of the Palarong Bicol.
- (d) To avail of this program, the following documents must be submitted to the Education, Scholarships, and Sports Office (ESSO):
 - 1. Form 138 (High School Card);

- 2. COMELEC Voter's Certificate of parent/s to ascertain residency;
- 3. Certificate of good moral character specifically stating therein that applicant was not involved in any serious disciplinary case;
- 4. Certification issued by the DepEd-Naga City Division attesting that applicant is a medalist/winner in the Palarong Panlungsod.

SECTION 2. HOLDING OF PALARONG PANLUNGSOD. The ESSO shall collaborate with the Department of Education for the conduct of the Palarong Panlungsod in the month of July every year.

SECTION 3. INSTITUTIONALIZING THE GRANTING OF CASH INCENTIVES TO WINNERS IN REGIONAL, NATIONAL AND INTERNATIONAL SPORTS

COMPETITIONS. (a) Medalists/Winners in regional, national and international sports competitions shall also be entitled to:

- 1. Regional Winners (based on highest medal)
 - 1. Gold (or equivalent) -P1.000.00 Silver (or equivalent)
 Bronze (or equivalent) -P750.00
 - -P500.00
 - 4. National Winners (based on highest medal)
 - 1. Gold (or equivalent) P3,000.00 2. Silver (or equivalent) P2,000.00 3. Bronze (or equivalent) P1,000.00 -P2,000.00-P1.000.00
 - 4. International Winners (based on highest medal)
 - 1. Gold (or equivalent)
 P6,000.00

 2. Silver (or equivalent)
 P5,000.00

 3. Bronze (or equivalent)
 P4,000.00
- (b) To avail of this program, the following documents must be submitted to the ESSO:
 - 1. Form 138 (High School Card);
 - 2. COMELEC Voter's Certificate of parent/s to ascertain residency;
 - 3. Certificate of good moral character specifically stating therein that applicant was not involved in any serious disciplinary case;
 - 4. Certification issued by appropriate office attesting that applicant is a medalist/winner in international, national or regional sports competition;

SECTION 4. INFORMATION DISSEMINATION. The Education, Scholarships and Sports Office and the Public Information Division of the City Mayor's Office shall conduct a massive information dissemination campaign about this Program through the local mass media particularly in the month of June prior to the conduct Palarong Panglunsod

A correspondence containing this program and such other scholarship programs or grants that the city or national government or any public or private entity as well as any foreign government or donor is sponsoring shall be sent to the principals or head teachers of all public and private elementary and high schools. Posting in their respective bulletin boards shall likewise be made.

SECTION 5. FUNDING. The amount necessary to fund this program shall be taken from the Special Education Fund (SEF).

SECTTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.
