Executive Order No. 2012-005

**AMENDING EXECUTIVE ORDER NO. 2011-030  
BY CREATING THE EXPANDED CITY  
LOCAL POVERTY REDUCTION TEAM (LPRAT)**

**WHEREAS**, on October 14, 2011, Executive Order No. 2011-030 was issued "Creating the City CBMS-cum-City Anti-Poverty Convergence Team" for the purpose therein stated;

**WHEREAS**, in pursuit of the policy of the national government and other key stakeholders to significantly reduce poverty in the country by 2016, the Bottom-Up Approach to Planning and Budgeting Process shall be piloted in 300 Local Government Units (LGUs) nationwide, 72 of which are in the Bicol Region;

**WHEREAS**, this project aims to ensure the inclusion of funding requirements for the development needs of these priority LGUs in the budget proposals of participating national government agencies;

**WHEREAS**, project implementation will be under the Anti-Poverty Convergence Program of the National Anti-Poverty Commission (NAPC), in collaboration with the Department of Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD), Department of Budget and Management (DBM) and civil society organizations (CSOs);

**WHEREAS**, the City Government of Naga believes that poverty reduction is the concern of every Nagueño, especially the city government and other stakeholders of Naga's sustainable development;

**WHEREAS**, there is a need to create an Expanded City Local Poverty Reduction Team (LPRAT);

**NOW THEREFORE**, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of powers vested upon me by law do hereby order the following:

**Section 1.** An Expanded City Local Poverty Reduction Team (LPRAT) is hereby created to be composed of the following:

**Section 2.** The City CBMS Expanded Local Poverty Reduction Team (LPRAT) shall have the following functions and responsibilities:


1. Participate in the preparation and formulation of the Local Poverty Reduction Action Plan (LPRAP)
2. Make sure that the LPRAP contains the programs and projects that will directly address the needs of the poor and the marginalized sectors
3. Take the lead in the crafting of solution concepts and identification of appropriate anti-poverty programs and projects that can address specific problems
4. Monitor and evaluate the accomplishments and outcomes of the implementation of the Local Poverty Reduction Action Plan.

**Section 3.** This Executive Order modifies Executive Order No. 2011-030 and shall take effect immediately.
