EXECUTIVE ORDER NO. 2012-008

**RECONSTITUTING THE CITY MAYORAL AWARDS
SCOMMITTEE FOR YEAR 2012:-**

WHEREAS, the search and selection of the annual City Mayoral Awards is a continuing tradition instituted by the Office of the Mayor of the City of Naga;

WHEREAS, these Awards include:

- a. Distinguished Mayoral Award (Highest Award);
- b. Special Mayoral Award; and
- c. Mayoral Recognition Award
- d. City Excellence Award

WHEREAS, these awards are presented to individuals or groups of native Nagueños, migrant Filipinos who have resided in Naga City for at least a year; and those born in the City of Naga, though may be residing elsewhere and have distinguished themselves by their exemplary achievements in various fields of endeavor, thereby contributing positive enhancement to Naga City's growth, honor and glory;

WHEREAS, conferment of these awards is one of the highlights of the annual Naga City Charter Day celebrations;

WHEREAS, there is a need to reconstitute the Naga City Mayoral Awards Committee in order to select this year's Mayoral Awardees;

NOW, THEREFORE, WE, JOHN G. BONGAT AND HER LYNN F. BALARES, Mayor and City Youth Mayor of the City of Naga, respectively, and by virtue of the powers vested in us by law, do hereby order the following:

SECTION 1. NOMINATION COMMITTEE – A nomination committee is hereby constituted that will take charge of accepting, searching and pre-screening nominees that will be submitted for evaluation and final selection of the Awards Committee. The nomination committee shall be composed of the following:

The Nominating Committee shall submit on or before May 31, 2012 the list of pre-screened nominees to the Awards Committee for evaluation and selection.

SECTION 2. – COMPOSITION - The Naga City Mayoral Awards Committee 2012 to be composed of the following representatives from various sectors is hereby constituted, to wit:

SECTION 3. – FUNCTIONS OF THE COMMITTEE – The Search Committee shall have the following responsibilities:

- a. To formulate the criteria, and general and specific guidelines of the selection process;
- b. To evaluate, validate, review, and select the 2012 Mayoral Awardees based from the list of nominees submitted by the Nominating Committee;
- c. To submit to the City Mayor, on or before June 5, 2012, the names of the Mayoral Awardees for approval and conferment during the Charter Day Celebration of the City of Naga on June 18, 2012;

The Selection Committee reserves the right to assign a nomination to an alternate category provided the nominator agrees to the reassignment.

SECTION 5. SEARCH COORDINATORS – Mr. Allen L. Reondanga of the City Mayor's Office and Ms. Zayda Fe Sancho Rifareal of the Arts Culture and Tourism Office are hereby named as Search Coordinators for this year's Mayoral Awards.

The search coordinators shall assist the Mayoral Nomination and Awards Committee, and other concerned bodies in the coordination and execution of the various activities of the Awards so as to come up with a prestigious 2012 Mayoral Awards Presentation.
