EXECUTIVE ORDER NO. 2018 - 009

EXPANDING AND AMENDING EXECUTIVE ORDER NO. 2016 - 050 "NAGA CITY BOARD OF TRAFFIC IMPROVEMENT AND STRATEGIES (B - TIS)", REASSIGNING NEW CHAIRPERSON, DEFINING ITS FUNCTIONS, AND PROVIDING FUNDS THEREFOR:-

WHEREAS, as a developing urban center, Naga City has to adjust to the increasing volume of vehicles and cope with the challenges of traffic management and engineering;

WHEREAS, the City has initiated various programs and projects such as the establishment recently of a new Traffic Management Center (TMC) comprised of three (3) units, namely, (1) the Traffic Enforcement Unit in collaboration with the NCPO - TEU; (2) the Traffic Regulation Unit, and (3) the Traffic Engineering Unit. The TMC shall be one of three (3) Divisions under the Public Safety Office (PSO), to address traffic concerns, the other two being the CDRRMO and the Naga City Rescue;

WHEREAS, the has closely coordinated with the Philippine National Police, Land Transportation Office, and the Land Transportation, Franchising, and Regulatory Board for the enforcement of traffic rules and regulations;

WHEREAS, there is a need to coordinate and consolidate the traffic management in Naga City for a more effective and efficient flow of vehicles and pedestrians especially in the major thoroughfares;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by Law, do hereby order the establishment of the NAGA CITY BOARD OF TRAFFIC IMPROVEMENT AND STRATEGIES (B - TIS).

Section 1. COMPOSITION. The Naga City B - TIS shall be composed of the following:

Section 2. FUNCTIONS. The Naga City B - TIS shall have the following functions:

- 1) Meet once a month;
- 2) Formulate and improve on a regular basis, or as need arises, the traffic plan particularly for the busy streets of Naga;
- 3) Formulate strategies on how to ease traffic, through encouragement of the use of alternate routes or side streets, etc;
- 4) Maximize use of traffic lights/signals;
- 5) Conduct studies and recommend legislations for adoption by the Sangguniang Panlungsod (SP);
- 6) Monitor traffic daily and recommend legislations for adoption by the Sangguniang Panlungsod (SP);
- 7) Coordinate and consult with public utility vehicle operators drivers' organizations, school and college/university administrators, and other stakeholders;
- 8) Perform such other functions consistent with or in pursuance of the above purposes.

Section 3. **FUNDING.** Funding for the Naga City B – TIS shall be sourced


Section 4. **EFFECTIVITY.** This Executive Order shall take effect immediately.
