EXECUTIVE ORDER NO. 2019-011

CREATING THE TECHNICAL WORKING GROUP OR PLANNING TEAM FOR THE GENERATION OF VALIDATED AND VERIFIED HOUSING RELATED DATA TO SUPPLEMENT THE PROPOSED LEGISLATION OF THE HOUSING AND URBAN DEVELOPMENT COORDINATING COUNCIL (HUDCC), NAMELY THE NATIONAL HOUSING DEVELOPMENT AND PRODUCTION BILL, ITS COMPOSITION, ROLES AND RESPONSIBILITIES

WHEREAS, the HUDCC is currently undertaking the preparation of a proposed legislation or the National Housing Development and Production Bill;

WHEREAS, the said bill is aimed at ensuring the automatic appropriation to the housing sector which will fund housing projects and programs of the government that addresses the housing need of the underprivileged, the homeless and families affected by natural and human induced disasters and calamities;

WHEREAS, to determine the budget for the housing sector's automatic appropriation, it is essential to generate validated and verified housing related data to support the proposed legislation with accurate statistics on housing backlog and funding requirement for housing production from 2020 to 2040;

WHEREAS, there is a need to activate the Local Shelter Plan (LSP) Technical Working Group or Planning Team which will be responsible with the validation of data as input to the proposed bill and in the formulation of updated LSP;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby create and mobilize the LSP Technical Working Group or Planning Team, to wit:

SECTION 1. COMPOSITION

The LSP Technical Working Group or Planning Team shall be composed of the following:

SECTION 2. ROLES AND RESPONSIBILITIES

The Technical Working Group or Planning Team will be responsible for the following:

- Data-gathering and processing of information relevant to the preparation of updated LSP;
- 2. Ensuring policy coordination and uniformity in operational directions for shelter planning;
- 3. Ensuring processing of information and the corresponding actions are in line with the national and local policies and standards;
- 4. Establishing or maintaining linkages with and seek substantial inputs from the appropriate national government agencies, civil society organizations and private sector groups in all stages of local shelter planning and development processes; and
- 5. Formulating or updating the LSP and initiating community validation and consultation.

SECTION 3. EFFECTIVITY. - This Executive Order shall take effect immediately.
