**EXPANDING THE MEMBERSHIP OF THE HEALTH EMERGENCY RESPONSE TASK FORCE**

**WHEREAS**, President Rodrigo Roa Duterte, in the evening of 14 June 2021, put Metro Manila, the epicenter of COVID-19 in the Philippines, under General Community Quarantine, but unfortunately raised to a higher quarantine classification several local government units across the country;

**WHEREAS**, Naga City is one of those placed under modified enhanced community quarantine (MECQ) starting 16 June 2021;

**WHEREAS**, this sudden upgrading of the city’s quarantine classification prompted other government agencies and well-meaning private organizations to express their interest to take an active part in the operations of the Health Emergency Response Task Force;

**WHEREAS**, consistent with the principles of people-empowerment that is embedded in the city’s brand of local governance and even advanced by the present administration, the city government welcomes with enthusiasm the participation of the aforesaid sectors to HERTF;

**NOW THEREFORE, I, NELSON S. LEGACION**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:


