CONSTITUTING AND ACTIVATING THE 2021 BAR EXAMINATIONS INCIDENT MANGEMENT TEAM (NAGA CITY BAR IMT) TO COORDINATE AND PREPARE FOR AND RESPOND TO ANY INCIDENTS AND EMERGENCIES THAT MAY ARISE DURING THE CONDUCT OF THE BAR EXAMINATIONS IN THE CITY OF NAGA

WHEREAS, pursuant to Bar Bulletin No. 23, s. 2021 and Bar Bulletin No. 29, s. 2021, issued by Supreme Court Associate Justice and 2020/21 Bar Examinations Chairperson Marvic M.V.F. Leonen, University of Nueva Caceres situated in Jaime Hernandez Avenue, Naga City has been designated, after assessment, negotiations, and initial ocular inspections, to be one of the local testing centers for the 2020/21 Bar Examinations;



WHEREAS, this is the first time that the Bar Examinations, the qualifying licensure examinations for lawyers in the Philippines administered and supervised by no less than the Supreme Court, will be conducted in Naga City;

WHEREAS, according to Bar Bulletin No. 28, s. 2021, the 2020/21 Bar Examinations are slated to be held on January 16, January 23, January 30 and February 6, 2022;

WHEREAS, to prepare for and respond effectively to any incident or emergency that may arise during the conduct of the Bar Examinations in Naga City, there is a need to set-up an integrated structure that will match the complexities and demands of this important event without being hindered by agency or jurisdictional boundaries;

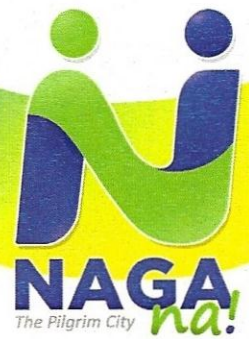
NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:


