



Barangay Clearance - refers to any and all documents issued by the barangays with or without corresponding fees as defined in their ordinances relative to, or in relation, to the issuance of business permit and locational/zoning clearance by the city, or any other permit as may be required.

Barangay Clearance Fees- is an amount imposed by the barangays through an ordinance and collected by the city/municipality in relation to the issuance of business permit and locational clearance by the city.

Business Permit - is a document that must be secured from the city or municipal government, through its Business Permits and Licensing Office (BPLO), for a business to legally operate in the locality.

Locational Clearance- is a clearance issued by the Zoning Administrator/Zoning Officer to a project that is imposed under the provisions of an existing Zoning ordinance of the City. It is a requirement for the issuance of Building Permit.

**SECTION 3. Authority to collect Barangay Clearance Fee of Business Related Transactions-** The City Treasurer is hereby authorized to collect Barangay Clearance Fee of the Twenty Seven (27) of the City of Naga, subject to the remittance of the fees collected to the respective Barangay.

**SECTION 4. Rate of Barangay Clearance Fee to be collected -** The rate of Barangay Clearance Fee to be collected by the City Treasurer for the issuance of a clearance, shall be computed in accordance with the subject Barangay Revenue Ordinance of a specific barangay.

**SECTION 5. Barangay Clearance Signatory -** Electronic Signature of Punong Barangay concern shall appear in all barangay clearance issued.

**SECTION 6. Reporting and Remittance -** The City Treasurer shall remit the Barangay Clearance Fee collected to the subject Barangay not later than seven (7) working days of the ensuing month, together with the list of the issued Building and Business Permit.

**SECTION 7. Separability Clause. -** If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby, shall remain valid and in full force and effect.

**SECTION 8. Repealing Clause. -** All Ordinances and rules/regulations which are inconsistent with the provisions of this ordinance are hereby deemed, modified and/or repealed accordingly.


