**AMENDING SECTION 3 OF EXECUTIVE ORDER NO. 2021-029 BY  
ENUMERATING THE FINAL LIST OF MEMBERS OF THE BAR  
EXAMINATION SUPPORT STAFF OF THE SUPREME COURT**

**WHEREAS**, Executive Order No. 2021-029 constituted and activated the 2021 Bar Examinations Incident Management Team (Naga City Bar IMT) to coordinate and prepare for and respond to any incidents and emergencies that may arise during the conduct of the Bar Examinations in the City of Naga this coming January 16, January 23, January 30 and February 6, 2022;

**WHEREAS**, under Section 3 of the said executive order, the Naga City Bar IMT is directed to at all times acknowledge that the conduct of the Bar Examinations stems from the Constitutional power of the Supreme Court to supervise admissions to the practice of law and, thus, to always coordinate closely with the Office of the Bar Chairperson and the Host Coordination Committee in the conduct of their operations;

**WHEREAS**, the Supreme Court has recently provided the final list of personnel who will serve as Bar Examinations Support Staff during the abovementioned Bar Examinations;

**NOW THEREFORE**, I, **NELSON S. LEGACION**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. AMENDMENT TO SECTION 3 OF EXECUTIVE ORDER NO. 2021-029.** Section 3 of Executive Order No. 2021-029 shall now be read as follows:

**“SECTION 3. CLOSE COORDINATION WITH THE OFFICE OF THE BAR CHAIRPERSON AND THE HOST COORDINATION COMMITTEE.** The Naga City Bar IMT must at all times acknowledge that the conduct of the Bar Examinations stems from the Constitutional power of the Supreme Court to supervise admissions to the practice of law and, thus, must always coordinate closely with the Office of the Bar Chairperson and the Host Coordination Committee in the conduct of their operations, to wit:

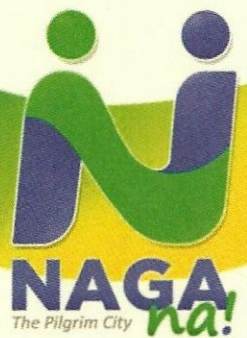


