ORDINANCE NO. 2021-081

AN ORDINANCE IMPOSING NEW CURFEW HOURS IN NAGA CITY, AMENDING FOR THE PURPOSE ORDINANCE NO. 2020-046, AS AMENDED BY ORDINANCE NOS. 2020-066 AND 2021-051.

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - Ordinance No. 2020-046, as amended by Ordinance Nos. 2020-066 and 2021-051, entitled: "An ordinance instituting measures to promote public health, safety and protection against the continuing threat of Covid-19 or any such emerging infectious disease, imposing penalties for violation thereof, and for other purposes", is hereby further amended specifically Section 10 thereof by changing the curfew hour, and by adding sub-sections thereto, now to read as follows:

"Section 10. Imposition of New Curfew Hours. As a further measure to achieve the purpose of this Ordinance, curfew hours from 12:00 midnight to 4:00 o'clock a.m. is hereby imposed upon all persons within the territorial jurisdiction of the City of Naga.

10.1 During curfew hours, no person shall be in a public place such as streets, alleys, parks and plazas, playgrounds, subdivision open spaces, subdivision roads, building and facilities where no legitimate business is normally transacted at nighttime, or in vacant/idle lot, or vacant/abandoned buildings/structures. *[Signature]*

10.2 To facilitate the observance of curfew hours, business which are normally open only for fixed period per day shall open only after 4:00 o'clock a.m. and close not later than 12:00 midnight. Businesses which are normally open 24/7 or even at night shall ensure that they do not serve as refuge for curfew violators.

10.3. To give ample time to workers/employees of business which closes at 12:00 midnight, an additional time of one (1) hour is hereby given for them to reach their places of residence, provided they can show Identification Card reflecting their employment and address of employer, for verification purposes.

10.4 All activities not regulated under pertinent issuances of the Inter-Agency Task Force (IATF) on Emerging Infectious Disease shall be covered by this ordinance."




