WHEREAS, stated in the Republic Act 9344 otherwise known as the Juvenile Justice and Welfare Act of 2006, as amended by Republic Act 10630 otherwise known as the Act Strengthening the Juvenile Justice System in the Philippines, provides for the Local Government Units to develop a Comprehensive Juvenile Intervention Program to address the concerns of the Children-At-Risk (CAR) as well as the Children-In-Conflict with the Law (CICL);

WHEREAS, the existing Comprehensive Local Juvenile Intervention Program of the City of Naga covering years 2015-2017 needs to be updated to cater present necessities of children, CAR, and CICL especially during the time of pandemic;

WHEREAS, on August 26-27, 2021 members of the Naga City Council for the Welfare and Protection of Children undergo workshop with the Department of Interior and Local Government (DILG) in the Formulation of the CLJIP. The Naga City Council for the Welfare and Protection of Children (NCCWPC) hereby created a Technical Working Group that has been tasked to update the current CLJIP of the city;
