**Invitation for Applicants for a
Permanent Eastbound Terminal for Public Utility Jeepneys and Van**

By virtue of Section 12 of Ordinance No. 2006-044, as amended, and the letter of the City Mayor dated May 11, 2021 signifying to the Sangguniang Panlungsod the need for an Eastbound Terminal for Public Utility Jeepneys (PUJs) and a succeeding letter dated December 12, 2021 to include Public Utility Vans (PUVs) in the said proposed permanent Eastbound Terminal, interested applicants for such Eastbound Terminal are herein invited to submit their proposal on or before January 3, 2022.

The terminal will cater to PUJs and PUVs bound for the following destinations: Pili, Partido Area, Rinconada Area, and Albay Province. The proposed terminal may be located in areas along Diversion Road (Roxas Avenue), Almeda Highway, or within the Central Business District II subject to compliance with specific regulations of the city government, the Department of Transportation and the Land Transportation and Regulatory Board.

A pre-submission conference will be held on December 17, 2021 at 2 P.M. at the Sangguniang Panlungsod session hall to explain the terminal requirements, procedures and terminal standards as well as to entertain questions from interested parties.

Applicants shall submit the documents listed under Annex A of Ordinance No. 2006-044 in five sets, each set arranged in a folder with tabs corresponding to the numbering of the documents per Annex A. Each folder shall be sealed in an envelopes and marked.
