RECONSTITUTING AND EXPANDING THE MEMBERSHIP OF THE NAGA CITY NUTRITION COMMITTEE, BY ADDING A REPRESENTATIVE FROM HELP LEARNING CENTER FOUNDATION, INC.

WHEREAS, the Naga City Nutrition Committee was created to oversee, plan and coordinate the nutrition and nutrition-related programs and projects of the city, pursuant to policies on nutrition;

WHEREAS, among the groups that face risks of malnutrition are persons with disabilities.

WHEREAS, the Naga City Nutrition Committee is composed of representatives from the private and public sectors, to ensure efficient and effective delivery of services.

WHEREAS, the incumbent members of the Naga City Nutrition Committee do not include a representative for the people with disabilities.

WHEREAS, to further improve the nutrition situation of the city, and to have a broader scope of implementation of its programs, projects, and policies among others, it would be beneficial for the city to include as member in the Naga City Nutrition Committee a representative of persons with disabilities, especially from private sectors.

WHEREAS, during the Fourth Quarterly Meeting of the Naga City Nutrition Committee held on December 3, 2021, the said Committee resolved to send an invitation to HELP Learning Center Foundation, Inc., a non-stock, non-profit, non-government organization that caters the needs and promotes the development of persons with disabilities, to become a member of the Naga City Nutrition Committee;

**NOW THEREFORE, I, NELSON S. LEGACION,** Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the inclusion of a representative from persons with disabilities in the Naga City Nutrition Committee, upon submission of its acceptance to become member thereof.




