



CONSTITUTING THE EVENT AND SUPPORT COMMITTEES FOR THE PEÑAFRANCIA FESTIVAL 2022 CIVIC EVENTS

WHEREAS, for over two years, the various civic and religious events of the Philippines' sole regional fiesta and Southeast Asia's biggest Marian Celebration, Naga's Peñafrancia Fiesta, were cancelled due to the COVID-19 pandemic;

WHEREAS, due to the city's relentless vaccination campaign and the public's strong support to programs designed in ending the pandemic, the city's COVID-19 situation has improved, and is currently under the lowest Alert Level;

WHEREAS, based on Arts, Culture and Tourism Office's data, the city's tourist arrivals declined from 1.5 million in 2019 to 379,000 in 2020 – a drop of 76% equivalent to 26 billion revenue loss;


WHEREAS, the conduct of Peñafrancia Festival civic and religious events will be supportive of the city's post pandemic socioeconomic recovery efforts, increasing the economic dynamism of Naga, and enhancing the Nagueños' sense of community;

WHEREAS, as to commence with the preparations and ensure the smooth implementation of the various activities identified for this year's celebration, there is a need to constitute, organize and create event and support committees, defining their functions, roles, and responsibilities, as well as the different activities that will be implemented and monitored by the same;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order and create the following Peñafrancia Fiesta event and support committees:

SECTION 1. CIVIC EVENT COMMITTEES. The following shall take charge of planning and smooth coordination and implementation of all the civic events:



SECTION 3. POWERS, DUTIES AND FUNCTIONS. The Event and Support Committees shall perform the following duties and functions:

- 1. Plan and ensure the smooth coordination and implementation of all Fiesta activities;
- 2. Encourage private sector participation. For this purpose, the Committee Chairpersons are hereby authorized to identify or appoint person/s who shall assist in the effective performance of their committees' duties and functions;

- 3. Find ways and means to support the successful implementation of the various Fiesta programs, events and activities;
- 4. Promote the festival both locally and internationally through various media outlets to ensure the optimal participation of visitors and tourists; and,
- 5. Perform such other acts which are necessary to effectively and meaningfully carry-out the mandate and functions of their respective committees.

SECTION 4. ADMINISTRATIVE SUPPORT STAFF. The City Events, Protocol and Public Information Office and the Arts, Culture and Tourism Office shall jointly provide administrative and technical support to the committees herein organized.

SECTION 5. FUNDING/OPERATING COSTS. All costs pertaining to the operation of Committees and Civic Events staging, including incidental and other expenses as well as appropriate personnel expenditures, as may hereinafter be identified shall be taken from the available funds of the City Government of Naga, subject to the usual accounting and auditing rules and regulations and taking into consideration Austerity Measures put in place in anticipation of the continued rise in the prices of fuel and other essential commodities.

SECTION 6. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately.
