**CONSTITUTING AND ACTIVATING THE 2022 BAR EXAMINATIONS  
INCIDENT MANAGEMENT TEAM (NAGA CITY 2022 BAR IMT) TO  
COORDINATE AND PREPARE FOR AND RESPOND TO ANY INCIDENTS  
AND EMERGENCIES THAT MAY ARISE DURING THE CONDUCT OF THE  
BAR EXAMINATIONS IN THE CITY OF NAGA**

**WHEREAS**, pursuant to Bar Bulletin No. 7, s. 2022, Naga City is one of the local testing centers for the 2022 Bar Examinations;

**WHEREAS**, the Bar Exam is the qualifying licensure examinations for lawyers in the country administered and supervised by no less than the Supreme Court of the Philippines;

**WHEREAS**, according to Bar Bulletin No. 6, s. 2022, the 2022 Bar Examinations will be held on November 9, 13, 16 and 20, barring unforeseen circumstances and contingencies which may necessitate a rescheduling of the same;

**WHEREAS**, to prepare for and respond effectively to any incident or emergency that may arise during the conduct of the Bar Examinations in Naga City, there is a need to set-up an integrated structure that will match the complexities and demands of this important event without being hindered by agency or jurisdictional boundaries;

**NOW THEREFORE, I, NELSON S. LEGACION**, Mayor of the City of Naga,



**SECTION 3. CLOSE COORDINATION WITH THE OFFICE OF THE BAR CHAIRPERSON AND THE HOST COORDINATION COMMITTEE.** The Naga City Bar IMT must at all times acknowledge that the conduct of the Bar Examinations stems from the Constitutional power of the Supreme Court to supervise admissions to the practice of law and, thus, must always coordinate closely with the Office of the Bar Chairperson and the Host Coordination Committee in the conduct of their operations, to wit:


