**AN ORDER RECONSTITUTING THE COMPOSITION OF THE NAGA CITY
URBAN DEVELOPMENT AND HOUSING BOARD (NCUDHB)**

WHEREAS, Ordinance No. 2019-056 amended the composition of the Naga City Urban Development and Housing Board (NCUDHB), which is the city's arm in the implementation and monitoring of pertinent provisions of Republic Act No. 7279 and the Kaantabay sa Kauswagan Program;

WHEREAS, the City Mayor's Office already received the CSO representatives of the Naga City People's Council and the representatives of the Philippine Institute of Civil Engineers and United Architects of the Philippines to the said board, as well as the result of the elections of the Naga City Urban Poor Federation Inc. relative to the same;

NOW, THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

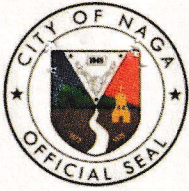
SECTION 1. COMPOSITION. The Naga City Urban Development and Housing Board is hereby reconstituted to be composed of the following:

SECTION 2. TERM OF OFFICE. The members of the Board shall serve a term co-terminus with the term of the City Mayor and the members of the Sangguniang Panlungsod.

SECTION 3. HONORARIA TO PRIVATE SECTOR MEMBERS. Members of the Board, except those from the government sector, shall receive an honorarium to defray their expenses in attending the functions of the Board in such amount as it may determine, to be included in its Annual Budget.

SECTION 4. INTERNAL RULES OF PROCEDURE. The Board shall promulgate its internal rules of procedure, including the guidelines on possible expulsion of erring members from the Board.

To declare a quorum in any meeting of the Board, however, it is sufficient that at least two each from the government, the urban poor sector and the non-government sector be present.

SECTION 5. CONDUCT OF NCUDHB MEETING. All members shall meet once a month, which said regular meeting shall be set during the first meeting of the group. An emergency meeting may be called upon if necessary when important matters must be decided at once.

SECTION 6. SEPARABILITY CLAUSE. Any portion or provision in this Executive Order that maybe declared unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to remain in full force and effect.


SECTION 7. REPEALING CLAUSE. All prior issuances and orders inconsistent herewith shall be deemed superseded, amended or repeated by this Order.

SECTION 8. EFFECTIVITY. This Order shall take effect immediately.
