CREATING THE LOCAL INTER-AGENCY COMMITTEE TO MONITOR AND PROVIDE NECESSARY INTERVENTIONS ON POSSIBLE HOUSING RELATED ISSUES RELATED TO THE UPCOMING MODERNIZATION OF THE PHILIPPINE NATIONAL RAILWAYS SOUTH LONG-HAUL PROJECT

WHEREAS, the National Housing Authority has informed the City Government of Naga of the proposed upgrading and modernization of the Philippine National Railways South Long-Haul Project;

WHEREAS, in anticipation of the possibility that there are individuals who may be adversely affected by the aforesaid project, an integrated structure that will offer interdisciplinary recommendations in providing assistance thereto and handling the same is imperative;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. LOCAL INTER-AGENCY COMMITTEE. The Local Inter-Agency Committee is hereby created with the following composition:

SECTION 2. AFFECTED BARANGAYS. Based on initial plans presented, Barangays Mabolo, Triangulo and Concepcion Pequeña shall be affected by the modernization of the PNR South-Long Haul Project. Thus, the Punong Barangays of Mabolo, Triangulo and Concepcion Pequeña shall also form part of the Local Inter-Agency Committee as members.

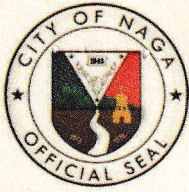
SECTION 3. EXPANDED MEMBERSHIP. To promote cooperation among all stakeholders of Naga, the following institutions are hereby enjoined to send a permanent representative or focal person to the Local Inter-Agency Committee:

- Department of Public Works and Highways
- Department of the Interior and Local Government
- Commission on Human Rights
- Philippine National Police
- Metro Naga Chamber of Commerce and Industry
- Department of Education
- Camarines Sur Electric Cooperative II
- Metro Naga Water District

SECTION 4. SECRETARIAT. The Housing and Settlements Development Office of the City Government of Naga shall serve as the Secretariat of and shall provide technical and administrative assistance to LIAC.

The LIAC Secretariat shall organize and make all necessary arrangements for LIAC meetings. It shall also record and monitor activities and milestones of the LIAC for reporting to relevant agencies as necessary.

SECTION 5. FUNCTION. The Local Inter-Agency Committee shall serve as the venue for information, consultation, monitoring and resolution of housing-related issues relative to the modernization of the Philippine National Railways South Long-Haul Project.




- a. Beneficiary Selection, Awards and Arbitration
