**RECOGNIZING THE PRESIDENTS OF THE BARANGAY CHILDREN
ORGANIZATION AS CHILD REPRESENTATIVES IN THE BARANGAY
COUNCIL FOR THE PROTECTION OF CHILDREN OF THE TWENTY-SEVEN
(27) BARANGAYS IN NAGA CITY**

WHEREAS, cited in Article 38 of Ordinance 2018-055 otherwise known as the Naga City Local Code for Children, the Barangay Children Organization and its Federation, the Naga City Council for the Welfare and Protection of Children (NCCWPC) and the 27 Barangay Councils for the Protection of Children (BCPC) shall organize a Barangay Children Organization. The organization primarily aims to group the children and plan programs for the children and plan programs for the promotion and protection of child's rights and welfare as well as to hear their own sentiments on the program for children;

WHEREAS, the Barangay Children Organization will form into a Federation and the President of the Federation of the FBCO shall serve as the Child Representative to the NCCWPC;

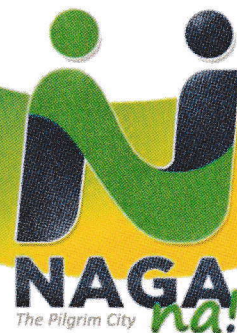


