RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS CAMARINES SUR 3RD DISTRICT ENGINEERING OFFICE TO FINANCE AND IMPLEMENT THE WIDENING PROJECT OF THE QUEBORAC DRIVE IN NAGA CITY: -

On joint and collective motion

WHEREAS, the City Government of Naga under its current administration has envisioned to make Naga a city where progress is all inclusive and everyone is happy and proud of their city and its government;

WHEREAS, essential to the attainment of this vision is availability of adequate standard infrastructure the facilities necessary to facilitate delivery of and enjoyment by the people of government services;

WHEREAS, the current city administration since the beginning of its initial term in 2019, has placed premium, in pushing further development in all its communities, establishing new schools, health care centers, new hospital, opening new roads and a number of other initiatives with the end in view of bringing its services closer to the people and inching forward to the realization of its long term vision;

WHEREAS, due to the Covid-19 Pandemic, however, our initiatives were hampered from moving forward and many proposed projects have been placed on hold as we encountered shortage of fund and redirection of our resources to combat the pandemic;

WHEREAS, as the whole country slowly roll back to normalcy, the City Government of Naga is again focusing to implement its projects but this time with an added challenge of sourcing funds from the National Government and other fund sources as the city continues to struggle with its financial resources;

WHEREAS, one of the identified priority projects of the City Government is the widening of Queborac Drive which serves as an important alternate road to entry and exits points of the City of Naga and which links the city to its neighboring town of Camaligan, Camarines Sur;

whereas, currently, this alternate road is experiencing added volume of vehicular traffic as the development in the area and in the town of Camaligan is taking shape, and with the planned resumption of face-face classes in all schools in the country, it is expected that the volume of vehicles plying the area will further increase adding pressure to this narrow two-lane road;

WHEREAS, to address this growing problem, there is a need to widen the existing Queborac Drive in Naga City;

NOW, THEREFORE, on joint and collective motion of the Honorable Members of the $14^{\rm th}$ Sangguniang Panlungsod,

BE IT RESOLVED, as it is hereby resolved, to earnestly request the Department of Public Works and Highways - Camarines Sur 3rd District Engineering Office to finance and implement the widening of Queborac Drive in Naga City.
