RESOLUTION APPROVING THE APPLICATION OF MR. ALLAN ABOGADO TO OPERATE A CARNIVAL AND PERYA AT THE VACANT LOT BESIDE SM CITY NAGA IN BARANGAY TRIANGULO, NAGA CITY, FOR THIS YEAR'S PEÑAFRANCIA FESTIVITIES FROM AUGUST 15 TO SEPTEMBER 30, 2022, SUBJECT TO COMPLIANCE BY THE APPLICANT WITH THE DOCUMENTARY REQUIREMENTS AND THE PAYMENT OF FEES:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter of Mr. Allan Abogado of Daet, Camarines Norte expressing his intent to put up a carnival and perya at the vacant lot beside SM City Naga in Barangay Triangulo, Naga City, for this year's Peñafrancia Festivities from August 15 to September 30, 2022;

WHEREAS, in the committee hearing of the Committee on Games and Amusement on the request of Mr. Abogado, the representative of the City Treasurer manifested that aside from payment of required fees, the operator of the carnival needs to first secure clearances from concerned government offices prior to operation thereof, and, additionally, the City Engineer's Office representative cited the requirement of a certification from a mechanical engineer as to the safety of the rides and another certification from an electrical engineer as to the safety of the electrical connection thereof;

WHEREAS, the grant of this approval to the operation of a carnival for this year's Peñafrancia Festivities is necessary to add color to the celebration and further encourage people to come to the city;


