RESOLUTION NO. 2022-694

RESOLUTION FAVORABLY RECOMMENDING TO THE PHILIPPINE NATIONAL POLICE, THROUGH POLICE LIEUTENANT GENERAL VICENTE DANAO, TO DECLARE AND IMPLEMENT A GUN BAN AND TO SUSPEND THE PERMIT TO CARRY FIREARMS OUTSIDE RESIDENCE (PTCFOR) WITHIN CITY OF NAGA DURING THE PEÑAFRANCIA FESTIVAL FROM SEPTEMBER 5-20, 2022:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 22, 2022 from Police Colonel Nelson A Pacalso, Acting City Director, Naga city Police Office, requesting for the passage of a resolution recommending the implementation of gun ban and suspension of Permit to Carry Firearms Outside Residence (PTCFOR) in the City of Naga during the Peñafrancia Festival from September 5-20, 2022;

WHEREAS, it is prescribed in Philippine National Police Memorandum Circular No. 2011-021 that provides the policies and procedures in the suspension of Permits to Carry Firearms Outside of Residence (PTCFOR), during local and other special events, including religious and cultural festivities, a gun ban may be imposed and validity of PTCFOR may be suspended per recommendation of the regional director and approval and order of the Chief PNP;

WHEREAS, the declaration and implementation of gun ban will prohibit private individuals, except those with occupations exposed to actual threats and imminent danger from lawless elements, to carry firearms outside of their residence and the validity of their respective PTCFORs, if they possess any, will be effectively suspended during the prescribed period;



whereas, the implementation of gun ban and suspension of the Permits to Carry Firearms Outside of Residence (PTCFOR) during the said period will significantly enhance the security measures of the Philippine National Police and significantly contribute in promoting peace and order in the city;

NOW, THEREFORE, on motion of Hon. Melvin Ramon G. Buenafe, seconded by Hon. Jessie R. Albeus and Hon. Joselito S.A. Del Rosario;

BE IT RESOLVED, as it is hereby resolved, to favorably recommend to the Philippine National Police through Police Lieutenant General Vicente Danao, to declare and implement a gun ban and to suspend the Permit to Carry Firearms Outside Residence (PTCFOR) within the City of Naga during the Peñafrancia Festival from September 5-20, 2022.
