WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the Resolution No. 05, S. 2022, of the City Development Council (CDC) of the City of Naga conditionally approving the proposed Comprehensive Development Plan (CDP), 2022-30 and endorsing the same to the Sanggunian Panlungsod for approval;
