A RESOLUTION DIRECTING THE CIVIL SOCIETY ORGANIZATION (CSO) DESK OFFICER TO ISSUE A NOTICE OF CALL FOR ACCREDITATION TO ALL CIVIL SOCIETY ORGANIZATIONS (CSOs) IN NAGA CITY AS COMPLIANCE TO THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) MEMORANDUM CIRCULAR NO. 2022-083: -

WHEREAS, the DILG issued Memorandum Circular No. 2022-083 which provides the guidelines on the accreditation of CSOs and selection of representatives to the local special bodies to strengthen people's participation in governance and development processes;

WHEREAS, through the Executive Order No. 2021-003, the Naga City Civil Society Organization (CSO) Desk was created to mobilize and ensure the participation of accredited and recognized CSOs in the various processes and activities of the local government;

WHEREAS, through the Executive Order No. 2021-003 the CSO desk officer is directed to assist CSOs in the application for accreditation and endorse the same to the Sangguniang Panlungsod upon completion of all requirements, as provided in City Ordinance 1995-092;

WHEREAS, following the guidelines of the DILG Memorandum Circular 2022-083, the CSO Desk officer has already conducted an inventory and updated the directory of the existing Civil Society Organizations in Naga City;

WHEREAS, the next step in the guideline is the issuance by the Sangguniang Panlungsod, in coordination with the CSO Desk Officer, of a notice of call for accreditation to all CSOs in Naga City;
