## REORGANIZING THE CITY ASSESSMENT COMMITTEE (CMAC) OF THE LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) OF THE CITY OF NAGA

WHEREAS, Section 399 of RA 7160, otherwise known as the Local Government Code of 1991, mandates the creation of Lupong Tagapamayapa, providing for its structures, procedures and powers, among others;

WHEREAS, the Department of the Interior and Local Government (DILG) has issued Memorandum Circular No. 2008-102, dated June 17, 2008, supplemental to DILG Memorandum Circular No. 2004-43, providing guidelines on the Functions of the City Awards Committee relative to the Lupong Tagapamapayapa Incentives Awards (LTIA);

**NOW THEREFORE**, by the powers vested in me by law, I, **NELSON S**. **LEGACION**, Mayor of Naga City, do hereby create the City Awards Committee (CAC) of the City of Naga, to wit:

**SECTION 1. COMPOSITION.** Per DILG 2008-102, the CAC shall be composed of the following:

Chairperson:	CLGOO, DILG
Vice-Chairperson:	DOJ Representative
Members:	Judge, Municipal Trial Court/ Municipal Circuit Trial Court (MTC/MCTC)
	PNP Representative

Two (2) NGO Representatives

**SECTION 2. ROLES AND RESPONSIBILITIES.** The CAC shall perform the following functions:

- a. Initiate and coordinate the necessary activities towards the successful implementation of the LTIA in the city;
- b. Disseminate information on the Awards to generate awareness and support from the public and private sectors within the city;

- c. Select and submit to the PAC the best performing Lupon within the city;
- d. Secure funding and counterpart prizes from the partner agencies and the private sector; and
- e. Plan and implement appropriate awarding ceremonies.

**SECTION 3. SECRETARIAT.** The DILG-Naga City will provide technical and secretariat services to the committee.

**SECTION 4. FUNDING**. The City of Naga, as provided in its General Appropriations Ordinance for the current year, shall provide funds for operational expenses of the committee.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately.
