## ACTIVATING THE ONE PINK MARCH INCIDENT MANAGEMENT TEAM TO PREPARE FOR AND RESPOND TO INCIDENTS AND EMERGENCIES THAT MAY ARISE DURING THIS LARGE GATHERING IN NAGA CITY

WHEREAS, the Office of the Vice President and numerous non-government organizations have relayed to the City Government of Naga that, on May 6, 2022, the second highest official of the Philippines, Her Excellency Vice President Ma. Leonor G. Robredo, will be visiting Naga City and hundreds of thousands of her constituents will be gathering in the city for such purpose;

WHEREAS, to prepare for and respond effectively to the incidents and emergencies that may arise during this large gathering, especially that it involves a high level official of the Republic of the Philippines, there is a need to set-up an integrated structure that will match the complexities and demands of this upcoming emergency without being hindered by agency or jurisdictional boundaries;

**NOW THEREFORE, I, NELSON S. LEGACION**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:




