CONSTITUTING THE NAGA CITY RESILIENCE COUNCIL (NCRC)

WHEREAS, the City Government of Naga envisions to build a self-reliant and caring city;

WHEREAS, to realize the aforesaid vision, there must be a body that will assess risk, prevent or reduce impacts of disaster and ensure development continuity;

WHEREAS, pursuant to the city's participatory and people-centered governance, said body must be composed of representatives from the private and public sectors to ensure that all insights and means for the city to be resilient are considered;

NOW, THEREFORE, I, NELSON LEGACION, Mayor of the City of Naga,
by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. NAGA CITY RESILIENCE COUNCIL. The Naga City Resilience Council (NCRC) is hereby established to develop a strategic framework and plan for a resilient Naga City.






