RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BICOL MEDICAL CENTER (BMC) RELATIVE TO THE AFFILIATION AND TRAINING OF THE MIDWIFERY STUDENTS OF THE CITY COLLEGE OF NAGA (CCN), SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated July 8, 2022, forwarding the proposed memorandum of agreement to be entered into by and between the City Government of Naga and the Bicol Medical Center relative to the affiliation and training of the midwifery students of the City College of Naga (CCN), an instrumentality of the City Government;

WHEREAS, the continuing growth of the City College of Naga especially in its midwifery course necessitates to explore partnership with institutions that can provide better training and education opportunities for its students;

WHEREAS, Bicol Medical Center, being the biggest hospital in the region catering to big population requiring midwifery service makes an ideal environment for training and education for midwifery students;

WHEREAS, to avail such an opportunity for the students of the City College of Naga, there is a need to grant authority to the City Mayor to enter into an agreement with BMC;

WHEREAS, the present request by the City Mayor is aimed towards that direction.

NOW, THEREFORE, on motion of Hon. Jose C. Rañola, seconded by Hon. Joselito S.A. del Rosario and Hon. Jessie R. Albeus,

BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor, to enter into a Memorandum of Agreement with Bicol Medical Center relative to the affiliation and training of the midwifery students of the City College of Naga (CCN), subject to the ratification by the Sangguniang Panlungsod.
