RESOLUTION RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN MR. EDUARDO F. MERCADO AND THE CITY GOVERNMENT OF NAGA INVOLVING THE PROPERTY OF THE FORMER COVERED BY TCT NO. 31951 WITH A TOTAL AREA OF ONE HUNDRED THOUSAND (100,000) SQUARE METERS SITUATED IN BARANGAY PACOL, NAGA CITY:-

On joint and collective motion

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 11, 2022, of His Honor, the City Mayor, forwarding the Deed of Donation executed by Mr. Eduardo F. Mercado in favor of the City Government of Naga involving a parcel of land covered by TCT No. 31951 with a total area of One Hundred Thousand (100,000) square meters situated in Barangay Pacol, Naga City;

WHEREAS, Resolution Nos. 94-279 adopted by the Sangguniang Panlungsod on October 12, 1994, authorized the City Mayor to enter into a deed of donation with Mr. Educardo Mercado involving a parcel of land situated in Barangay Pacol, Naga City, with a total area of five (5) hectares;

WHEREAS, on December 7, 1994, the Sangguniang Panlungsod further adopted Resolution No. 94-342 authorizing the City Mayor to negotiate and accept the additional five (5) hectares lot located in Pacol, Naga City, to be donated by Mr. Eduardo)F. Mercado;

WHEREAS, these parcels of land comprise the property now occupied by the Metro Naga Sports Complex in Pacol, this city, which has been venue of at least two (2) Palarong Pambansa events, and numerous other national and regional sports events;

WHEREAS, this deed of donation formalizes the transfer of ownership of the subject parcels of land with sincere appreciation and deep gratitude to the benevolence and kindness of Mr. Eduardo F. Mercado.
