RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ENVIRONMENTAL MANAGEMENT BUREAU (EMB)-REGION V RELATIVE TO THE GRANT OF ONE (1) UNIT 20-FOOTER CONTAINER AND SIXTY-THREE (63) UNITS 100L CAPACITY YELLOW BINS WITH ROLLER AS PART OF THEIR SUPPORT TO LGU NAGA CITY IN THE PRELIMINARY DISINFECTION AND STORAGE FACILITIES FOR COLLECTED COVID-19 RELATED WASTE, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 6, 2022, of Engr. Joel P. Martin, City Solid Waste Management Officer, requesting for an authority to the City Mayor to enter into a Memorandum of Agreement with Environmental Management Bureau-Region V, relative to the grant of one (1) unit 20-footer container and sixty-three (63) units 100L capacity yellow bins with roller as part of their support to LGU Naga City in the preliminary disinfection and storage facilities for collected Covid-19 related waste;

WHEREAS, the threat of Covid-19 Pandemic still persists although local cases have already been substantially decreased to almost nil in recent weeks;

WHEREAS, part of numerous measures instituted by the government to arrest the spread of the Covid-19 virus including private individuals and households are the use of protective equipment which are regularly disposed of on a day-to-day basis;

WHEREAS, in many cases, these equipment and supplies were found inappropriately disposed or stored in inappropriate containers while awaiting disposal;

WHEREAS, the Environmental Management Bureau-Region V, in its effort to assist LGUs in managing appropriate disposal of their Covid-19 related waste, offers containers appropriate for preliminary disinfection and storage of Covid-19 related waste;
