**ESTABLISHING THE NAGA CITY SOCIAL PROTECTION
FOR CHILDREN TEAM**

WHEREAS, it is the declared policy of the State under the 1987 Constitution to defend the “right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development”;

WHEREAS, in times of calamities and emergencies, it is the children who are the most vulnerable and gravely affected;

WHEREAS, there is a need to create a multi-agency structure that will be address the needs of children during times of calamities and emergencies in order to ensure that they will be able to get pass the trauma, become resilient and grow as caring and self-reliant individuals;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. NAGA CITY SOCIAL PROTECTION FOR CHILDREN TEAM. The Naga City Social Protection for Children Team is hereby created, with the following composition:

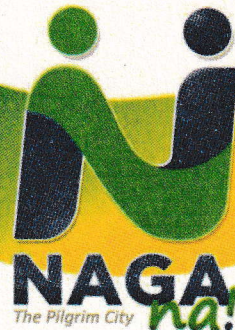

Representatives of the following offices shall form part as members of the team:

1. City Social Welfare and Development Office
2. City Planning and Development Office
3. City Health Office
4. Naga City Hospital
5. City Nutrition and Population Office
6. Arts, Culture and Tourism Office
7. City Environment and Natural Resources Office

8. City Agriculturist's Office
9. City Disaster Risk Reduction and Management Office

The following institutions shall be invited to send representatives as members of the Naga City Social Protection for Children Team:

- a. Sangguniang Panlungsod Committee on Children
- b. Naga City Council for the Welfare and Protection of Children
- c. Philippine National Police
- d. Liga ng mga Barangay
- e. Naga City People's Council

SECTION 2. FUNCTIONS. The Naga City Social Protection for Children Team shall have the following tasks:

- a. To craft and forward policies and programs that can be considered by the Naga City Resilience Council to be incorporated in their plans;
- b. To spearhead the implementation of the aforesaid policies and programs during times of disasters and emergencies;
- c. To coordinate with other government agencies and the private sector in carrying out programs and activities that will serve the children who are in a disadvantage position during times of disasters and emergencies;
- d. To formulate plans and programs that will mitigate the aftermath effects of disasters and emergencies to children;
- e. To render report to the Naga City Resilience Council and to the City Mayor on the activities undertaken; and,
- f. To perform all other duties and functions that may be necessary to provide children with utmost care and protection in times of disasters and emergencies and to get pass the trauma of such unfortunate events, become resilient and grow as caring and self-reliant individuals

SECTION 3. SECRETARIAT. The City Social Welfare and Development Office shall serve as Secretariat of the Naga City Social Protection for Children Team. It shall provide assistance to the team in administrative and technical matters.




SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
