**WHEREAS**, the City of Naga and the Province of Camarines Sur have been declared Pilgrimage Capitals of the Bicol Region by virtue of Presidential Proclamation No. 33, Series of 2010;

**WHEREAS**, after a two-year hiatus, thousands of pilgrims from different parts of the country and the world will once again come to Naga to participate in major religious processions and civic events of the annual Peñafrancia Festival;

**WHEREAS**, Naga City Disaster Risk Reduction and Management Council has recommended the suspension of classes at all levels in both public and private learning institutions, as well as work in government offices, on certain days to ensure public safety and order, and effectively manage vehicular and human traffic, as well as reduce congestion, inconvenience and/or emergencies;

**NOW THEREFORE, I, NELSON S. LEGACION**, Mayor of Naga City,  
by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CLASS SUSPENSION.** Classes at all levels in both public and private learning institutions in Naga City are hereby ordered suspended on the following days:

19 September 2022, Monday	Post Peñafrancia Fiesta

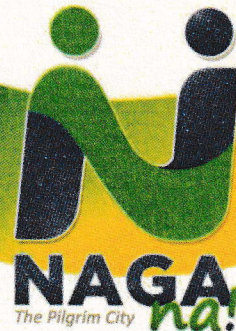
## SECTION 2. WORK SUSPENSION IN GOVERNMENT OFFICES.

Work in Government Offices within the territorial jurisdiction of Naga are ordered suspended on 9 September 2022, Friday.



Also, all heads of government agencies/offices, if required by the exigencies of public service, may require their employees to report and render work on the aforesaid date.

**SECTION 3. SUSPENSION OF WORK IN PRIVATE ESTABLISHMENTS.** Employers in the private sector, in the exercise of management prerogative and in coordination with their respective safety and health committee or safety officer or any other responsible company officer, may suspend work on any of the above-mentioned dates to ensure the safety and convenience of their employees and customers.


**SECTION 4. PEÑAFRANCIA FESTIVAL HOLIDAY.** Since the Solemnity of the Our Lady of Peñafrancia will fall on September 18, 2022 (Sunday) based on the Archdiocese of Caceres' calendar, the **Peñafrancia Fiesta Special Non-Working Holiday in Naga City is hereby set on September 16, 2022** being the "Friday immediately preceding the Solemnity or Feast of Our Lady of Peñafrancia" in accordance with Presidential Proclamation No. 654, Series of 2013.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately.
