

EXECUTIVE ORDER NO. 2022-030

RECONSTITUTING THE NAGA CITY PRICE COORDINATING COUNCIL

WHEREAS, Republic Act No. 7581 (Price Act), particularly Rule VI of its Implementing Rules and Regulations (IRR), mandates the creation of a Local Price Coordinating Council to protect the consumers by stabilizing the price of and supply of basic necessities and prime commodities and by prescribing measures against undue price increases especially during emergency situations;

WHEREAS, because of changes in the personnel of the City Government of Naga, national government agencies and other stakeholders, there is a need to reconstitute the Naga City Price Coordinating Council;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. NAGA CITY PRICE COORDINATING COUNCIL. The Naga City Price Coordinating Council is hereby created to be composed of the following:

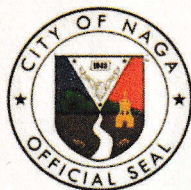

SECTION 2. POWERS AND FUNCTIONS. The Naga City Price Coordinating Council shall:

1. Coordinate and rationalize the city's programs to stabilize prices and supply of basic necessities and prime commodities;
2. Recommend to the National Price Coordinating Council or to the necessary government agencies suggested retail prices (SRP) and/or the price ceilings for certain basic necessities and/or prime commodities;
3. Conduct in-depth analysis on causes for price fluctuations; and
4. Recommend actions to correct unwarranted price increases and supply shortages.

SECTION 3. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
