RESOLUTION EXPRESSING SUPPORT TO THE CONDUCT OF SYNCHRONIZED RABUZ IN THE 27 BARANGAYS OF NAGA CITY INITIATED BY THE LIGA NGA MGA BARANGAY OF THE CITY:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the resolution adopted by the Liga ng mga Barangay of the City of Naga recommending to His Honor, the City Mayor, to set the second and fourth Saturday of each month for the conduct of synchronized rabuz in the 27 barangays of Naga City and to allocate funds for the purpose;

WHEREAS, one of the primary reasons of the Liga for initiating the said program is the increasing number of Dengue cases reported in the city which as expressed in the same resolution can be prevented by maintaining cleanliness of the surroundings;

WHEREAS, this initiative of the Liga ng mga Barangay under the leadership of our colleague, Hon. Ma. Corazon M. Peñaflor is very commendable, timely, and necessary in light of the onset of the rainy season which in the experience of our health system also ushers more incidence of dengue cases across the country;

WHEREAS, dengue is a deadly viral disease caused by a bite of the disease-carrying mosquitoes which thrive in dirty places and stagnant water, thus, as correctly cited in the same Liga resolution, can be prevented by maintaining cleanliness of our surroundings;

WHEREAS, the maintenance of cleanliness is a shared communal responsibility and one way of stressing everyone's role in this endeavor is the conduct of regular rabuz activity in the 27 barangays of the city;

NOW, THEREFORE, on motion of Hon. Ma. Corazon M. Peñaflor, seconded by Hon. Joselito S.A. del Rosario, Hon. Jessie R. Albeus, and Hon. Antonio B. Beltran;

BE IT RESOLVED, as it is hereby resolved, to express support to the conduct of synchronized rabuz in the 27 barangays of Naga City initiated by the Liga nga mga Barangay of the city.

LET COPIES of this resolution be furnished His Honor, the City Mayor, and the 27 Sangguniang Barangay of Naga City through the Liga ng mga Barangay President for their information.
