

EXECUTIVE ORDER NO. 2022-037

ESTABLISHING THE NAGA CITY SOCIAL PROTECTION TEAM

WHEREAS, in times of calamities and emergencies, the underprivileged sectors become more vulnerable and depressed;

WHEREAS, there is a need to create a multi-agency structure that will address the needs of underprivileged sectors during times of calamities and emergencies in order to ensure that they will not be susceptible to abuses;

WHEREAS, Nagueños, especially the underprivileged, should be provided with interventions to become resilient, caring and self-reliant individuals;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. NAGA CITY SOCIAL PROTECTION TEAM. The Naga City Social Protection Team is hereby created, with the following composition:

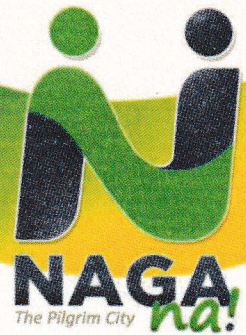

9. Metro Public Employment and Service Office

- d. Naga City Council for Women
- e. Philippine National Police
- f. Liga ng mga Barangay
- g. Naga City People's Council

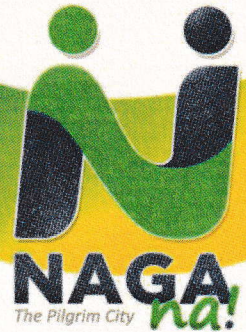
SECTION 2. FUNCTIONS. The Naga City Social Protection Team shall have the following tasks:

- a. To craft and forward policies and programs that can be considered by the Naga City Resilience Council to be incorporated in their plans;
- b. To spearhead the implementation of the aforesaid policies and programs during times of disasters and emergencies;
- c. To coordinate with other government agencies and the private sector in carrying out programs and activities that will serve the indigents and underprivileged who are in a disadvantageous position during times of disasters and emergencies;
- d. To formulate plans and programs that will mitigate the aftermath effects of disasters and emergencies to the vulnerable sectors;
- e. To render report to the Naga City Resilience Council and to the City Mayor on the activities undertaken; and,
- f. To perform all other duties and functions that may be necessary to provide the vulnerable sectors with utmost care and protection in times of disasters and emergencies, ensure that they will not be susceptible to abuses and to introduce interventions for them to become resilient, caring and self-reliant individuals

SECTION 3. SECRETARIAT. The City Social Welfare and Development Office shall serve as Secretariat of the Naga City Social Protection Team. It shall provide assistance to the team in administrative and technical matters.
