
**NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:**

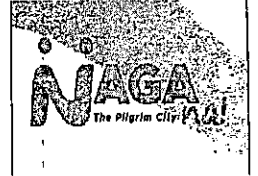



# CONTRACT AGREEMENT

THIS AGREEMENT made the 22nd day of NOVEMBER, 20 22 between the City Government of Naga, Naga City, Philippines (hereinafter called "the Entity") of the one part and Biomerjs Trading Corporation of Block 12, Lot 71 King St., Regency Town Homes, Sampaloc II, Dasmariñas City, Cavite (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Medicines and Medical Supplies (OLLI)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Forty Thousand Five Hundred Fifty Six & 55/100 (P 40,556.55) Pesos** (hereinafter called "the Contract Price").

  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Forty Thousand Five Hundred Fifty Six & 55/100 (P 40,556.55) Pesos** or such other sums as may be ascertained, Biomerjs Trading Corporation agrees to Supply and Deliver the Medicines and Medical Supplies in accordance with his/her/its Bid.


4. The *City Government of Naga* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
