A RESOLUTION CONSTITUTING A COMMITTEE TO SPEARHEAD THE CONDUCT OF THE INVENTORY OF STREETS IN NAGA CITY:-

WHEREAS, the recent establishment of new growth areas in Naga City caused for the opening of more roads in the city which further provided for improved movement of people, goods, and services in the city;

WHEREAS, to better serve for a more efficient mobility within the city, these roads necessitates naming for purposes of proper identification to better guide motorists, tourists, and the general public, as well as facilitate prompt and accurate delivery of postal and other matters;

WHEREAS, aside from these new roads, numerous city streets are still unnamed or without proper identification, which is not being helpful in the location of addresses and hamper effective implementation and delivery of services and programs of the local government;

WHEREAS, there is a need for the local government to conduct an inventory of the existing city streets, in order to properly organize and harmonize the necessary naming and/or renaming, ensure rightful consideration of historical and cultural significance for the city and relevance to the heritage of the place or character of the neighborhood, and avoid instances of duplication or redundancies;

WHEREAS, this also necessitates the creation of a special committee to spearhead the conduct of the inventory of city streets and cause for the crafting of the Code of Naga City Streets;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario duly seconded by Hon. Jose C. Rañola, Hon. Salvador M. del Castillo and Hon. Ma. Corazon M. Peñaflor;

BE IT RESOLVED, as it is hereby resolved, to adopt a resolution constituting a committee for the purpose hereunto stated:

Section 1- Composition. The following shall compose the committee:

Chairman: City Mayor

Co-Chair: SP Committee Chair on Culture and the Arts

Members: City Assessor City Engineer

Page - two -

City Planning and Development Coordinator Head, Arts, Culture and Tourism Office Head, City Events, Protocol and Public Information Office President, Liga ng mga Barangay

To be invited:

Representative, Metro Naga Chamber of Commerce and Industry Representative, Department of Education Representative, Religious Sector Representative, Naga City People's Council Representative, Historical groups

Section 2. Functions

- 1) Conduct a review and inventory of existing city streets;
- 2) Facilitate necessary research and studies, and coordinate with concerned individuals, agencies and institutions, for the naming and renaming of city streets;
- 3) Facilitate the crafting of the Code of Naga City Streets which will detail the guidelines and general principles in the naming and renaming of city streets, in time with the commemoration of the $75^{\rm th}$ City Charter Anniversary;
- 4) Perform other functions for purposes of the attainment of the objectives of this Resolution.

Section 3. In consultation with the City Mayor, may add other member/s to the committee as it sees fit.
