CONTRACT AGREEMENT

THIS AGREEMENT made the 2nd day of MAT , 20_23 between the City Government of Naga. Naga City, Philippines (hereinafter called "the Entity") of the one part and Qualifirst Health, Inc. of Unit 909 Citystate Centre Bldg., 709 Shaw Blvd., Bgy. Oranbo, Pasig City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Medical Supplies for use of Naga City Hospital patients (1st and 2nd quarters), Project/ Contract Reference Number: 2023-011 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Ten Thousand Two Hundred Fifty (Php 110,250.00) Pesos (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- The City Government of Naga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
