RESOLUTION CONFIRMING THE AUTHORITY OF HIS HONOR, THE CITY MAYOR, AND RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF NAGA AND ENRIQUE L. LEE AND TERESITA L. LEE RELATIVE TO A PROPERTY OF THE LATTER WITH AN AREA OF THIRTY NINE (39) SQUARE METERS WHICH WILL BE TRAVERSED BY THE CONSTRUCTION OF DRAINAGE FOR UPVILLE SAN FELIPE, A SOCIALIZED HOUSING PROJECT OF THE CITY, SUBJECT TO CERTAIN TERMS AND CONDITIONS:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated December 12, 2022 of His Honor, the City Mayor, following-up as to the action of the Honorable Sangguniang Panlungsod on the matter indicated in the letter dated July 13, 2020 by then Attorney II, Rebbekah Grace G. Maraño, particularly on the request for ratification of the Memorandum of Agreement executed between Enrique L. Lee and the City Government of Naga;

WHEREAS, in the said Agreement, the city shall sell to the Lee siblings a portion of the city's property in Barangay Carolina presently utilized as a site for socialized housing project identified as Lot 8, Blk 12, Isarog Heights, Phase I, Barangay Carolina, Naga City, which will serve as the latter's access road to their property, and the necessary Deed of Conveyance shall only be executed after survey to be conducted which shall subsequently be ratified by the Sangguniang' Panlungsod;

WHEREAS, copy of the said Memorandum of Agreement is hereto attached as integral part of this resolution;

WHEREAS, finding the ratification of the said Memorandum of Agreement to be in order and necessary in the furtherance of the city's Socialized Housing Program;

NOW, THEREFORE, on motion of Hon. Jessie R. Albeus, seconded by Hon. Ghiel G. Rosales, Hon. Vidal P. Castillo, Hon. Salvador M. del Castillo and Hon. Ma. Corazon M. Peñaflor;

BE IT RESOLVED, as it is hereby resolved, to confirm the authority of ZHis Honor, the City Mayor, and to ratify the Memorandum of Agreement entered into by and between the City Government of Naga and Enrique L. Lee relative to a property of the latter with an area of Thirty Nine (39) square meters, which will be traversed by the construction of drainage for Upville San Felipe, a Socialized Housing Project of the city, subject to the following terms and conditions:

1. To submit an annex to the MOA with the following inclusions:

- a. That upon the execution of an Absolute Deed of Sale between Enrique L. Lee & Teresita L. Lee, and the City Government of Naga, certain limitations will be imposed upon the former parties, to ensure that the surrounding will be socialized housing project will not adversely affected, and that the integrity of the existing roads around the area will not be greatly diminished;
- b. An annex transferring the last provision of the first paragraph of the Terms and Conditions to the First Party;
- c. Inclusion of a provision that the price of the property that will be purchased by the Lee siblings will be based on the current Fair Market Value as recommended by the City Appraisal Committee; and
- 2. That the copy of the Minutes of the consultation meeting conducted by HSDO Head, Engr. Rolando SI. Campillos, be submitted to the City Legal Office.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT is entered this in Naga City, Philippines by and between:

ENRIQUE L. LEE, of legal age, Filipino, and with residence and postal address at General Luna Street, Naga City, for himself and duly authorized to represent his co-owners by virtue of three separate Special Power of Attorneys (SPAs) executed by Raul L. Lee¹, Vicente L. Lee², and TERESITA L. LEE, likewise of legal age, Filipino, and with residence and postal address at General Luna Street, Naga City, hereinafter collectively referred to as the "FIRST PARTY";

and

CITY GOVERNMENT OF NAGA, a public corporation organized and existing under the laws of the Republic of the Philippines, represented by Hon. NELSON S. LEGACION, City Mayor, of legal age, married, Filipino and with office address at 2nd Floor, Naga City Hall, J. Miranda Ave., Concepcion Pequeña, Naga City, hereinafter referred to as the "SECOND PARTY";

WITNESSETH:

WHEREAS, the FIRST PARTY is the owner of aportion of a parcel of land situated in Brgy. San Felipe, Naga City, covered by TCT No. 31334, more particularly described as follows:

"A parcel of land (Lot 3-B-2-1, being a portion of Lot 3-B-2, situated in the Barangay San Felipe, City of Naga, Island of Luzon, Bounded on the N., along line 3-4, by Lot 3-B-1-A; on the E., along line 4-1, by Lot 3-B-1-A; on the S., along line 1-2, by Lot 8-B-6-2; on the W., along line 2-3, by Lot 3-B-2 (remaining portion); Beginning at a point marked "1" on the plan being N. 45 deg. 36' E. 550.01m. from BBM No. 15, Naga Cadastre,

thence S. 80 deg. 29' W. 1.11 m. to point 2; thence N. 34 deg. 58' W. 38.59 m. to point 3;

thence N. 55 deg. 00'E. 1.00 m. to point 4;

thence S. 34 deg. 58' E. 39.078 m. to point of beginning,

containing an area of THIRTY-NINE (39) SQUARE METERS."

WHEREAS, the SECOND PARTYintends to construct a drainage system for the UPVILLE San Felipe, a socialized housing project of the City Government of Naga, and the said drainage system will traverse the above-described property of the FIRST PARTY;

WHEREAS, the SECOND PARTY owns a parcel of land in Carolina, Naga City which is adjacent to the property owned by the FIRST PARTY, and the latter needs to acquire an access road for the said parcel of land;

NOW THEREFORE, in view of the foregoing premises, the parties hereto hereby agree upon the following terms and conditions, to wit:

- 1. The FIRST PARTY intends to voluntarily, freely, and perpetually allow the SECOND PARTY to utilize the said portion of the above-mentioned parcel of land with an area of THIRTY-NINE (39) sqm., free from all other liens and encumbrances for the purpose of constructing a drainage system for the benefit of the UPVILLE Urban Poor Village, a socialized housing project in Brgy. San Felipe, Naga City. The SECCOND PARTY shall not change, alter, or modify the use of the property or a portion thereof for a purpose other for which it was allowed perpetual use of. The SECOND PARTY further agrees that the property or any portion thereof shall not be sold or transferred for valuable consideration to any third persons;
- 2. The **SECOND PARTY** shall sell a portion of the property situated in Brgy. Carolina, Naga City, presently utilized as a site for socialized housing project, to the FIRST PARTY which will serve as an access road for the FIRST PARTY, and the said portion shall be determined by both parties through a geodetic survey to be conducted in the said area. After said survey, the FIRST PARTY and the SECOND PARTY shall execute a Deed of Absolute Sale which shall be ratified by the Sangguniang Panlungsod;
- 3. Both parties, their heirs, assigns and successors-in-interest shall be bound by the terms and conditions set forth in this Agreement.




