WHEREAS, through Ordinance No. 2008-053, the City of Naga declares as a policy that noise is a public nuisance and poses danger to the health of the people;

WHEREAS, Section 3a of Ordinance No. 2004-109 that prescribes guidelines for the establishment, operation and maintenance of night clubs, cabarets, videoke bars, bars, discos and other establishments of similar nature in the City of Naga, by expanding its coverage to include videoke bars, and other establishments serving alcoholic drinks, and for other purposes, states that:

"SECTION 3. - There is hereby prescribed certain guidelines to be observed for the operations of "Videoke Bars" in the City of Naga, as follows:

a. The establishment and operation of Videoke Bars is hereby prohibited to operate within One Hundred (100) lineal meters from any public or private schools, church, public building or residential areas within the jurisdiction of the City of Naga, and that the owners/operators of video bars are required to install sound proofing materials/devise within their establishments;"

WHEREAS, finding the grant of this authority to be in order and necessary in the filing of necessary case in court against the violators;

NOW, THEREFORE, on joint and collective motion of the 14th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor, the City Legal Office and/or the City Environment and Natural Resources Office to institute the necessary case against the certain business owners for violation of Ordinance Nos. 2008-053 and Section 3a of 2004-109.
