## RESOLUTION NO. 2023-031

RESOLUTION APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY ABELLA, CITY OF NAGA FOR CALENDAR YEAR FROM JANUARY 1 TO DECEMBER 31, 2023 AS EMBODIED UNDER BARANGAY APPROPRIATION ORDINANCE NO. 2022-10-002, INVOLVING THE AMOUNT OF EIGHT HUNDRED THIRTY THOUSAND FOUR HUNDRED TWO PESOS & 40/100 (P830,402.40) IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action was the 1st Indorsement dated December 21, 2022 from the City Budget Officer, this city, forwarding the Annual Budget of Sangguniang Kabataan of Barangay Abella, this city, for Calendar Year 2023 as embodied under Barangay Appropriation Ordinance No. 2022-10-002 involving the amount of P830,402.40 with the information that his office rendered technical assistance in the preparation of the said annual budget and that they initially reviewed and found the same to have conformed with the existing budgetary rules and regulations and in accordance with the provisions of the Local Government Code of 1991;

WHEREAS, finding the said annual budget to be in order and complied with the provisions of R.A. No. 7160;

NOW, THEREFORE, on joint and collective motion of the 14th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to approve the Annual Budget Sangguniang Kabataan of Barangay Abella, City of Naga for Calendar Year from January 1 to December 31, 2023 as embodied under Barangay Appropriation Ordinance No. 2022-10-002, involving the amount of Eight Hundred Thirty Thousand Four Hundred Two Pesos & 40/100 (P830,402.40) in conformity with existing budgetary rules and regulations and in accordance with the provisions of the Local Government Code of 1991.
