RESOLUTION EXTENDING THE PROVISIONAL PERMIT TO RUBY SHELTER BUILDERS AND REALTY CORPORATION FOR THE OPERATION OF TEMPORARY EASTBOUND TERMINAL FOR PUBLIC UTILITY JEEPNEYS AND PUBLIC UTILITY VANS BOUND FOR PILI, PARTIDO AREA, RINCONADA AREA, ALBAY PROVINCE AND ONWARDS LOCATED IN CENTRAL BUSINESS DISTRICT II, FOR A PERIOD OF SIX (6) MONTHS:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated December 19, 2022 of Atty. Ruby Jane Sia-Isla, Operations and Business Development, Ruby Shelter Builders and Realty Development Corporation, applying for the extension of the Provisional Terminal Permit which has already lapsed in accordance with the provision of Ordinance No. 2006-044;

WHEREAS, on June 14, 2022, through Resolution No. 2022-570, the Ruby Shelter Builders and Realty Development Corporation was granted the first renewal to operate a temporary eastbound terminal for Public Utility Jeepneys and Public Utility Vans bound for Pili, Partido Area, Rinconada Area, Albay Province and onwards for a period of six (6) months;

WHEREAS, Section 14 of Ordinance No. 2006-044, authorizes the City Mayor to issue a provisional permit to applicant to operate a terminal for a period of six (6) months, renewable for six-month period, subject to the concurrence by the Sangguniang Panlungsod from first renewal onward;

WHEREAS, finding the extension of the provisional permit to be in accordance with the existing city ordinances and relevant laws, and the same being advantageous to commuters and to the City of Naga, in general;

BE IT RESOLVED, as it is hereby resolved, to extend the provisional permit to Ruby Shelter Builders And Realty Corporation for the operation of Temporary Eastbound Terminal for Public Utility Jeepneys and Public Utility Vans bound for Pili, Partido Area, Rinconada Area, Albay Province and onwards located in Central Business District II, for a period of six (6) months.
