RESOLUTION NO. 2023-035

RESOLUTION EARNESTLY REQUESTING THE CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE (CDRRMO) AND THE LIGA NG MGA BARANGAY TO CONDUCT AN INVENTORY OF ALL CITY AND BARANGAY-OWNED PROPERTIES OR EQUIPMENT RELATED TO DISASTER RISK MANAGEMENT:

Sponsor: Hon. Joselito S.A. del Rosario,

WHEREAS, through the request of the Liga ng mga Barangay, the Sangguniang Panlungsod adopted Resolution No. 2023-034, endorsing to His Honor, the City Mayor Nelson S. Legacion, the request of the Liga ng mga Barangay - Naga City for the City Government of Naga to provide rescue boats and other rescue equipment to the frequently flooded barangays of Naga chargeable against the city disaster fund;

WHEREAS, the 14th Sangguniang Panlungsod concurs with the sentiment of the Liga ng mga Barangay that:

- 1. That in the past few days, the city has been experiencing continuous moderate to heavy rains as a result of the shear line affecting the eastern portion of Southern Luzon, which led to severe flooding in the various parts of the city and adversely affected the lives of Naguenos;
- 2. That it is indeed alarming that, in contrast to a storm, such as Typhoon Paeng which only caused minimal flooding that are mainly concentrated on the eastern corridor of the city, the shear line have caused double of the said typhoon's volume of water to flood Naga; and
- 3. The city should always be prepared with necessary equipment, such as rescue boats, flashlights, boots and other equipment to provide: immediate succor to Naguenos during emergencies.

WHEREAS, it is deemed necessary that an inventory of city and barangay-owned disaster-related equipment be first effected in order the determine the insufficiency;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario, seconded by Hon. Ghiel G. Rosales and Hon. Ma. Corazon M. Peñaflor;

BE IT RESOLVED, as it is hereby resolved, to earnestly request the City Disaster Risk Reduction Management Office (CDRRMO) and the Liga ng mga Barangay to conduct an inventory of all city and barangay-owned properties or equipment related to disaster risk management.
