WITNESSETH, that:

WHEREAS, the above-named HEIRS are the only surviving and lawful heirs of the late EUFEMIA SATIN, CONSTANCIA S. CUETO, LEONIDES S. CUETO, BRICCIA ADELAIDA S. CUETO, ASUNCION S. CUETO, and ESTER S. CUETO, EUFEMIA SATIN being the late mother of the HEIRS and CONSTANCIA S. CUETO, LEONIDES S. CUETO, BRICCIA ADELAIDA S. CUETO, ASUNCION S. CUETO, and ESTER S. CUETO being the late siblings of the HEIRS who died single and without any child.

WHEREAS, it is to the very best interest of the HEIRS to adjudicate unto themselves the entire estate extrajudicially in the form and manner hereinafter set forth;

That the HEIRS hereby covenant and further warrant that should there be preterition or omission of one, some, or all of the compulsory heirs in the direct line, whether living or not at the time of the execution of this Deed, the terms and conditions of this Deed will not be invalidated/nullified. Instead, the HEIRS shall proportionately oblige themselves to pay to the omitted Heirs or the latters' heir(s) the share which belongs to him/them, in accordance with the rules of succession under the Civil Code of the Philippines.

FURTHERMORE, for and in consideration of the amount of SIX HUNDRED PESOS (PhP600.00) per square meter or the total sum of FOURTEEN MILLION TWO HUNDRED NINETY TWO THOUSAND PESOS (PhP14,292,000.00) Philippine Currency, receipt of the full amount of which is hereby acknowledged from the CITY GOVERNMENT OF NAGA as represented by the City Mayor, ATTY.

RESOLUTION DETERMINING THE FAIR MARKET VALUE OF LAND DECLARED IN THE NAME OF EUFEMIA SATIN & CONSTANCIA CUETO LOCATED AT BARANGAY SAN FELIPE, THIS CITY, INTENDED FOR PUBLIC USE.

WHEREAS, the Sangguniang Panlungsod of Naga in response to the intent or offer to sell made by Ms. Asuncion R. Joaquin pertaining to the property of Eufemia Satin and Constancia Cueto being potential for public and or for Socialized Housing Project;

WHEREAS, the property offered is seen to have been strategically beneficial and appropriate for the purpose is the property of Eufemia Satin and Constancia Cueto located in Barangay San Felipe, this City, Described as Lot 3216-B containing an area of 23,820 square meters;

WHEREAS, for the intent of acquisition thereof, the determination of market value is elemental and the evaluation as to its viability is essential;

WHEREAS, the Sangguniang Panlungsod of Naga, has directed this committee to undertake appropriate valuation and assessment of the subject property;

WHEREAS, in compliance thereof, this committee has instructed the City Assessor's Office to conduct an ocular inspection thence submit an appraisal report pertaining thereto;

WHEREAS, on August 13, 2021, an appraisal Report dated August 12, 2021 was submitted to this committee for review and evaluation;

WHEREAS, on August 16, 2021, this committee called for a conference to discuss among others, the above mentioned Appraisal Report on the property of Satin and Cueto;

WHEREAS, during deliberation, noted on the subject property's location is the absence of an access road which will impede its development. Also, it was contemplated that the suitable mode for its acquisition is through expropriation;

WHEREAS, this committee, after consideration of the significant viewpoints, proposes that a portion of the property be allotted for Road-Right-of-Way as manifested in the appraisal report.

WHEREAS, in conclusion, this committee finds the Appraisal Report to be substantial and fitting, that the value thereof is reflective of the fair market value of the subject property.

WHEREAS, premises considered, on joint and collective motion of the members of this committee;

BE IT RESOLVED, as it is hereby resolved, that the market value of the land owned by Satin and Cueto intended for public uses located in Barangay San Felipe, this City, is at FORTY NINE MILLION SEVEN HUNDRED SIXTY FOUR THOUSAND PESOS (P 49,764,000.00) for the entire area of TWENTY THREE THOUSAND EIGHT HUNDRED TWENTY (23,820) SQUARE METERS.
