RESOLUTION RATIFYING THE COMPROMISE AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF NAGA AND ALFREDO C. BARON AND SPOUSE, SHIRLEY DISPOLAN, AND BIENVENIDO O. NOVELO AND SPOUSE, BEATRIZ NACARIO, RELATIVE TO THE ACQUISITION OF THE LATTER'S PROPERTY COVERING AN AREA OF 52,181.2 SQUARE METERS LOCATED IN BARANGAY PACOL, NAGA CITY, FOR THE CITY'S ONE TIME BIG TIME SOCIALIZED HOUSING PROGRAM:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated January 27, 2023 of His Honor, the City Mayor requesting for the ratification of the Compromise Agreement entered into by and between the City Government of Naga and Alfredo C. Baron and spouse, Shirley Dispolan, and Bienvenido O. Novelo and spouse, Beatriz Nacario, relative to the acquisition of the latter's property covering an area of 52,181.2 square meters located in Barangay Pacol, Naga City, for the city's One Time Big Time Socialized Housing Program;

WHEREAS, on July 5, 2022, the Sangguniang Panlungsod enacted Ordinance No. 2022-054, exercising the power of, eminent domain over a parcel of land, measuring One Hundred Thirty Thousand Four Hundred Fifty Three (130,453) Square Meters registered in the name of the members of Bienvinido O. Novelo, Alfredo Baron, Rogelio B. Federico, Heirs of Ebelio A. Sabater, and Heirs of Lebio A. Ulan, with Transfer Certificate of Title Nos. 007,008,009, 010,011,012,013,014,015, 016,017,018,019, and 020 situated in Barangay Pacol, Naga City, for the purpose of the City Government of Naga's proposed housing program, appropriating the amount of Forty Five Million Six Hundred Fifty Eight Thousand Five Hundred Fifty Pesos (P45,658,500.00) chargeable against the proceeds from the city's loan with the DBP, subject to the final determination of the amount necessary as just compensation therefor, and authorizing the City Mayor to file the necessary expropriation proceedings in court and the City Legal Officer to appear in the pre-trial thereof and enter into compromise agreement;

Baron and spouse Shirley Dispolan, and Bienvenido O. Novelo and spouse Beatriz Nacario;

COMPROMISE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Compromise Agreement is made and entered into by and between -

The CITY GOVERNMENT OF NAGA, a local government unit created under Republic Act No. 305, represented herein by City Mayor NELSON S. LEGACION, Filipino, of legal age, married and with office address at City Mayor's Office, 2F City Hall Building, City Hall Compound, J. Miranda Avenue, Naga City, hereafter referred to as the PLAINTIFF,

-and-

ALFREDO C. BARON, of legal age, Filipino, married to Shirley Dispolan, and a resident of Barangay Pacol, Naga City, BIENVENIDO O. NOVELO, of legal age, Filipino, married to Beatriz Nacario, and a resident of Barangay Cararayan, Naga City, hereafter referred to as the DEFENDANTS BARON and NOVELO;

WITNESSETH:

WHEREAS, all Defendants in this present case are co-owners of fourteen (14) parcels of land all situated at Barangay Pacol, City of Naga, which are respectively covered by Transfer Certificates of Title Nos. 007, 008, 009, 010, 011, 012, 013, 014, 015, 016, 017, 018, 019, and 020;

WHEREAS, as co-owners, each defendant has a one fifth (1/5) share in the ownership of each of the above-mentioned fourteen (14) parcels of land;

WHEREAS, PLAINTIFF, in its desire to acquire the above-mentioned parcels of land for the implementation of its One Time Big Time Socialized Housing Project, offered to buy a Nine Thousand Five Hundred Three (9,503) square meter portion of the parcel of land covered by TCT No. 016¹, a Five Thousand Twenty (5,020) square meter portion of the parcel of land covered by TCT No. 020², and the entirety of the rest of the parcels of land covered by the above-mentioned titles from the all the DEFENDANTS in this present case, which offer the latter refused, prompting the PLAINTIFF to institute this present complaint for expropriation for the acquisition of the foregoing parcels of land as summarized below

WHEREAS, after further negotiations subsequent to the filing of this present Expropriation Case, DEFENDANTS BARON and NOVELO have arrived at an understanding with the PLAINTIFF and have agreed to settle this case amicably with respect to their respective share in the above-enumerated parcels of land totaling two fifth (2/5) thereof;

WHEREFORE, for and in consideration of the foregoing, the PLAINTIFF and DEFENDANTS BARON and NOVELO hereby AGREE and bind themselves to the foregoing terms and conditions:

- 1. Just Compensation for DEFENDANTS BARON and NOVELO's share in the above-described parcels of land shall be at Three Hundred Fifty Pesos (PhP350.00), Philippine Currency, per square meter or a total of EIGHTEEN **MILLION** TWO HUNDRED SIXTY THREE **THOUSAND** FOUR HUNDRED TWENTY **PESOS** (PhP18,263,420.00) for the total area of Fifty Two Thousand One Hundred Eighty One point Two (52,181.2) square meters, representing DEFENDANTS BARON and NOVELO's two fifth (2/5) share in each of the above-described fourteen (14) parcels of land;
- 2. To formalize this Agreement, DEFENDANTS BARON and NOVELO shall execute in favor of the PLAINTIFF Deed/s of Absolute Sale and/or such other Deed/s of Conveyance, including Settlement of Estate, if necessary, to formally convey in favor of Plaintiff their respective shares in the parcels of land subject of this present case. Payment of the above-agreed Just Compensation as purchase price shall be made to DEFENDANTS BARON and NOVELO (i) upon execution of such Deed and other necessary documents to formalize the conveyance, (ii) its ratification by the Sangguniang Panlungsod of Naga City, and (iii) the submission to the PLAINTIFF by DEFENDANTS BARON and NOVELO of all documents necessary to cause the registration in the name of the Plaintiff of the subject parcels of land or annotation in the pertinent titles of the conveyance.
- 3. PLAINTIFF shall assist DEFENDANTS BARON and NOVELO in securing exemption from Capital Gains Tax due them and shall shoulder the payment of other taxes and fees, such as the Documentary Stamp Tax, Transfer Taxes, registration fees, etc., due from the transfer of the above-enumerated parcels of land from DEFENDANTS BARON and NOVELO to the name of the PLAINTIFF;

4. Upon approval by the Honorable Court of this Compromise Agreement and pending compliance by DEFENDANTS BARON and NOVELO of the foregoing terms and undertakings, the PLAINTIFF shall be allowed possession of their respective shares in the subject parcels of land and is hereby permitted to implement its socialized housing project over the same portions.
