RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO A DEED OF DONATION WITH THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA) RELATIVE TO A SIX HUNDRED (600) SQUARE- METER CITY PROPERTY SITUATED ALONG ALMEDA HIGHWAY, CONCEPCION GRANDE, NAGA CITY, TO BE DONATED TO THE LATTER PURPOSELY FOR THE CONSTRUCTION OF ITS REGIONAL OFFICE BUILDING, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated November 25, 2022 from His Honor, the City Mayor, respectfully endorsing the Deed of Donation between the City Government of Naga and the Cooperative Development Authority relative to a Six Hundred (600) Square-Meter city property situated along Almeda Highway, Concepcion Grande, Naga City, to be donated to the latter purposely for the construction of its Regional Office Building;

WHEREAS, the said 600 square-meter lot within the Almeda Development Site is proposed to be donated for the purpose where part of the said structure will also be the new offices of the Naga City Cooperatives Office and Council;

WHEREAS, finding the grant of this authority to the Honorable City Mayor to be in order and that the Deed of Donation is a pre-requisite by the National Government in allocating necessary funding by FY 2024;

NOW, THEREFORE, on motion of Hon. Ghiel G. Rosales, seconded by Hon. Joselito S.A. del Rosario;

BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor to enter into a Deed of Donation with the Cooperative Development Authority relative to a Six Hundred (600) Square-Meter city property situated along Almeda Highway, Concepcion Grande, Naga City, to be donated to the latter purposely for the construction of its Regional Office Building, subject to the ratification by the Sangguniang Panlungsod.
