



MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and executed by and between:

The **EMBASSY OF THE PEOPLE'S REPUBLIC OF CHINA IN THE REPUBLIC OF THE PHILIPPINES**, herein represented by **AMBASSADOR HUANG XILLIAN**, with office address at 4896 Pasay Road, Dasmarinas Village, Makati City, Metro Manila, hereinafter referred to as the "**DONOR**";

The **CITY GOVERNMENT OF NAGA**, herein represented by **MAYOR NELSON S. LEGACION** with principal office at _____ Juan Miranda Avenue, Barangay Concepcion Pequeña, Naga City 4400, hereinafter referred to as the "**Partner**".

WITNESSETH:


THAT the **DONOR** has recognized the role of the **PARTNER** in providing basic services and facilities to its constituents;

THAT for and in consideration of its desire to construct **Basketball Court** for the sports development and socio-economic advancement of constituents of the Partner, the **DONOR** hereby undertakes to raise funds in the amount of **TWO MILLION TWO HUNDRED FIFTY-TWO THOUSAND SIX HUNDRED PHILIPPINE PESOS (P2,252,600.00)** to be donated for the construction of the aforesaid facility in favor of the **PARTNER, Philippines**;

THAT the **PARTNER**, as recipient of the donated amount, hereby **ACCEPTS** and **ACKNOWLEDGES**, without qualification whatsoever, the kindness and act of donation of the **DONOR**, and hereby expresses its appreciation and gratitude for the kindness and generosity of the **DONOR**;

THAT the **DONOR** shall make full fund payment and pay total amount by check directly to the **PARTNER** after receipt of an original copy of this Memorandum of Agreement, signed by all parties and duly acknowledged by a notary public;

THAT, upon receipt of the aforesaid fund, the **PARTNER** shall provide the **DONOR** an Official Receipt;



THAT the PARTNER shall supervise the implementation of the project to ensure that the Contractor that will construct the aforesaid facility will complete the construction of thereof within 90 calendar days after due award to him of the project in observance of Philippine procurement laws, rules and regulations, and the PARTNER shall also ensure that the quality of the project and compliance with all laws, rules and regulations, including building standards and the external appearance design, are observed and project status updates are regularly provided to the DONOR;

THAT the PARTNER hereby agrees and binds to manage the funds for the completion of the project and render it operational;

THAT the PARTNER shall provide to the DONOR a detailed statement of expenditure of the donation upon completion of the project;


