Pursuant to **Section 10.00 of Appendix 17 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184** and the Decision dated 27 February 2023, which, pursuant to Section 6.2(c) of the Implementing Rules and Regulations of R.A. 9184, became final on March 14, 2023, the City Government of Naga hereby issues this Blacklisting Order to the entity/ies hereafter stated:

J-Marbela Construction and Supply is hereby **SUSPENDED** and **DISQUALIFIED** from participating in all government procurement –

- for 1 year starting from 21 March 2023 until 21 March 2024
 permanently/in perpetuity


