CREATING A TECHNICAL WORKING GROUP FOR THE FORMULATION OF A COMPREHENSIVE DRAINAGE AND FLOOD CONTROL MASTER PLAN IN THE CITY OF NAGA

WHEREAS, because of its location in the eastern seaboard of the Philippines, the City of Naga, in particular, and the entire Bicol Region, in general, are vulnerable to typhoons

WHEREAS, Naga City usually experiences heavy flooding which affects the socioeconomic condition of its constituents;

WHEREAS, a comprehensive and multi-array of interventions must be implemented by the city government in order to mitigate the incidence of flooding and lessen its adverse impact against the people of Naga;

WHEREAS, to draft the Naga City Comprehensive Drainage and Flood Control Master Plan in the City of Naga, a technical working group must be created;

NOW THEREFORE, I, NELSON S. LEGACION, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. TECHNICAL WORKING GROUP ON COMPREHENSIVE DRAINAGE AND FLOOD CONTROL MASTER PLAN. The Technical Working Group on Comprehensive Drainage and Flood Control Master Plan is hereby constituted, with the following composition:

District Engineer, Department of Public Works and Highways (DPWH) Camarines Sur 3rd District Engineering Office or his designated representative

SECTION 2. SECRETARIAT. The City Engineer's Office shall serve as Secretariat of the Technical Working Group. It shall provide assistance to the committee in administrative and technical matters.

SECTION 3. FUNCTIONS. The Technical Working Group on Comprehensive Drainage and Flood Control Master Plan is hereby tasked to:

- a. Create an inventory of the existing flood control systems in Naga City;
- b. Analyze the capacity of and gaps in the existing flood control systems in Naga City;
- c. Hold surveys, consultation meetings, workshops and other activities that will help in the formulation of the Naga City Comprehensive Drainage and Flood Control Master Plan;
- d. Integrate and finalize studies, research findings and consultation outputs;
- e. Submit quarterly reports to the City Mayor as to the status of their work; and,
- f. Perform all other functions that are necessary in the crafting and approval of the Naga City Comprehensive Drainage and Flood Control Master Plan

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
